Nikolaos G. Georgarakis is a researcher at the National Center of Social Research. He studied Political Science in Panteion University and completed his post-graduate studies in Political Science and Political Sociology in the University of Paris (Paris II), as a scholar of both the "Alexander Onassis" Foundation and the State Scholarship Foundation.

He served as Secretary General of the National Centre for Public Administration and Local Government of the Ministry of Administrative Reform & E-Governance from February 2010 until September 2012. He also served as the Director of the National School of Public Administration and deputy Secretary and Coordinator of the Secretariat of the OP "Clisthenes" for the modernisation of the Public Administration. He was a national expert in the Committee for Public Management (PUMA) of the Organisation of Economic Cooperation and Development (OECD) for several years. N.G. Georgarakis served as a special scientist on issues of Administrative Organisation at the Ministry of Interior, Public Administration & Decentralisation, as well as a Studies & Research Advisor at the National Centre for Public Administration & Local Government on issues regarding Public Management.
