Summary Profile

Vasiliki Georgiadou is the Director and President of the Board of Directors of the National Center for Social Research (EKKE) in Greece. She is also a professor of Political Science and Political Sociology at the Department of Political Science and History at Panteion University of Social and Political Sciences. Previously, she served as the Director of the Centre for Political Research at Panteion University. She studied Political Science at Panteion University in Athens and the Institute of Politology in Münster, Germany. She holds a Ph.D. with summa cum laude from the Faculty of Philosophy at the Westphalian Wilhelms University of Münster. Her current research interests focus on far-right parties and movements, populism, radicalism, political violence, and violent extremism. She has led and participated in numerous research projects focusing on political behavior, violence, extremism, and trust in governance. She has published extensively in peer-reviewed journals, including *Electoral Studies*, *Party Politics*, *Nations and Nationalism*, *Zeitschrift für Politikwissenschaft*, *Journal of Modern Greek Studies*. She received scholarships from the German Academic Exchange Service (DAAD) for both her doctoral studies and subsequent postdoctoral research. She has been a regular member of the *National Council against Racism and Intolerance in Greece (2016-2019)* and the *Greek National Committee for Human Rights (2015-2018)*. She is a member of the committee for the Prevention and Treatment of Violence and Juvenile Delinquency (2024-25).
